SERVICES TO BE PROVIDED

- (1) Up to _____ hours of actual on-site photographic time. We arrive 30-60min ahead of your start time to set up as needed to execute this agreement.
- (2) Up to _____ edited images delivered electronically with in ____ days following the event.
- (3) All images to be delivered electronically for download from private web link to be provided by the photographer to the client.
- (4) Any image prints or photo souvenirs may be ordered at an additional cost through the website and are not included as part of this agreement.

AGREEMENT

This agreement contains the entire understanding between the client and the photographer.

Confirmation: A signed photography event contract and 50% deposit are necessary to confirm the stated event services from the photographer.

Cooperation: The client and the photographer consent to happily cooperating and communicating with each other to achieve the best possible result within the understanding of this contract. When possible, it is recommended that the photographer be provided with a helper, someone who knows most of the guests who will point out key individuals to be photographed.

Schedule: Our shooting schedule, style of working and experience are designed to achieve a great set of event photos for the client, accomplished with good humor and enjoyed by all concerned. Both the client and the photographer therefore agree that punctuality and cheerful cooperation are essential to producing outstanding photographic results. In cases where the event is not running on time (for example, extreme lateness by one of the clients' guests,) we cannot guarantee to take our normal set of photos, although in such circumstances we will do our absolute best to meet your needs within the parameters of this agreement.

Paparazzi Event Guests: All your guests have digital cameras and camera phones, and all your guests will want to take photographs at key times. In the spirit of cheerful cooperation the client agrees to give the photographer precedence over guests in order to take photographs required for the event services described above. The photographer cannot be held liable for a lack of event photos if guests taking their own photos of the key moments continually interrupt the photographer's work.

Copyright Law: The copyright of the photographs remains with the photographer. RAW files are not available as part of this agreement. The images taken by the photographer are for personal use by the client and their friends and relatives. The sale, publication or any commercial use of the photographs is not allowed without prior written permission from the photographer.

Release: The client grants the photographer and it's legal representatives or heirs, and assigns the irrevocable and unlimited consent to use the photographs of the clients for editorial, competition, advertising and any other purposes and in any manner, and to alter the photographs without restriction; and to copyright the images. The client hereby releases the photographer and its legal representatives, heirs and assigns from all liability and claims in connection with the images.

Limit of Liability: If a photographer is too ill or becomes injured and cannot supply the services specified above the photographer will try to book a replacement event photographer. If the photographer is unavailable and a replacement photographer cannot be found, then liability is limited to a refund of any payments received.

The photographer has working methods in place to prevent loss or damage to your images. However, there is the unlikely possibility that images may be lost, stolen or destroyed for reasons in or beyond the control of the photographer. In these circumstances liability is limited to the return of fees paid for the services or part thereof according to the percentage of images supplied.

Booking Fee/Deposit: In the event of the clients canceling the event for whatsoever reason the deposit is nonrefundable. Your deposit may be used toward a future session or event up to one year from the original date of your event.

Payment: Full payment is expected upon arrival to perform the job. We accept all forms of payment on site – credit card, PayPal, Venmo, check payable to Steven Weisz or cash. The event representatives are responsible for payment when we arrive and check in with them.

Other Services: This contract is for the photography services and electronic delivery of the licensed digital images only. Additional services such as providing high resolution digital images on physical media, touch ups, or editing beyond the contracted number of images are available as a separate order and for an additional fee.

Force Majeure: no party shall be liable in damages or have the right to terminate this agreement for any delay or default in performing hereunder if such delay or default is caused by conditions beyond its control including, but not limited to: acts of God (such as hurricanes, earthquakes, flooding, fire), government restrictions including the denial or cancellation of any export or other necessary license, wars, terrorist acts, insurrections and or any other cause beyond the reasonable control of the party whose performance is affected. Should client's event be cancelled, postponed or otherwise adversely impacted as a result, there shall be no refunds for payments already received by the photographer but the photographer will use all reasonable efforts to work with the clients to produce the event at a later date if necessary subject to photographers availability.

We have understood the contents of this contract and agree to the terms therein.
